NATIONAL RESEARCH SERVICE AWARD POSTDOCTORAL FELLOWSHIP FOR HEMATOLOGY TRAINING PROGRAM AT MEMORIAL SLOAN-KETTERING CANCER CENTER

National Research Service Award postdoctoral fellowships are available for a multidisciplinary hematology training program at the Memorial Sloan-Kettering Institute for Cancer Research. The program will cover fundamental research in hematology as well as identification and characterization of erythropoietin-responsive cells, the refinement of clinical bone marrow transplantation, genetic disorders in red cell enzymes, and the interaction of leukocytes with other hematopoietic elements. Fellowships are awarded for one year with the possibility of renewal and are open to United States citizens or permanent residents who hold doctoral degrees and have had no more than three years of postdoctoral experience.
